




Missouri Counties with Senior Levies

MoALSO Background How It Started

- At the 2019 Senior Levy Board Annual Meeting, over 25 levy board counties met and determined that the creation of an association would be beneficial to them and the older adults they serve
- The organization's first by-laws were adopted and signed in March of 2021

MoALSO Background Association Responsibilities

•Assist and support members through networking, education, and advocacy

•Provide opportunities for levy board members to share information and discuss concerns in their counties

•Promote the levy fund and encourage and assist new counties with levy passage

•Provide access to data-based statistics and best practices to support advocacy efforts and senior services

•Provide a platform for members' participation in the democratic process to impact state legislation/ regulation/policy

•Support existing counties with information for levy fund administration

•Work strategically with the Missouri Association of Area Agencies on Aging (ma4) and Silver-Haired Legislature



MoALSO – MO Foundation for Health Grant | **Timeline**

- Fall 2021: MoALSO applied to receive funding from the Missouri Foundation for Health to help move forward the work of developing the association and strengthening the network of senior levy funds
- November 2021: MoALSO Issues an RFP for Senior Levy Association Coordination
- December 2021: MoALSO hires the Penman Group
- January 2022 December 2023: Grant period



MFH Grant | Grant Deliverables – Year 1

Completed:

- ✓ Monitor and track legislative bills impacting senior levy funds
- ✓ Design, develop, and maintain a MoALSO website
- ✓ Organize a monthly association meeting with relevant educational sessions
- ✓ Advertise meetings to non-members
- ✓ Develop a senior levy educational toolkit
- Conduct interviews with persons successful passing a senior levy or placing one on the ballot



MFH Grant | Grant Deliverables – Year 1

Outstanding/In-Progress

- Increase the number of association members from 10 to 15 (currently at 12 members)
- Assess the commitment of 15 communities to initiate efforts to place a senior levy fund on the local ballot



MFH Grant | **Deliverables – Year 2**

Outstanding

- Provide training to 10 counties who are committed to implementing a senior fund efforts
- Develop a plan and budget to amend the Missouri State Statute to increase the senior levy tax

Voting ID Changes | Preparing Older Adults for November (HB 1878)

Photo ID: Enacts photo ID requirements by removing non-photo forms of ID Missourians may rely on to verify their identities at the poll, such as voter registration cards

"Early Voting" – Allows two weeks of no-excuse absentee voting/early voting, but only for voters casting ballots in person (not for ballots by mail)

Voter Registration Payment – Prohibits anyone from being paid for voter registration, preventing organizations who do voter registration in their work from being paid to do so.



Voting ID Changes | Preparing Older Adults for November (HB 1878)

Absentee – Makes it illegal to provide someone with an absentee ballot application

Disability Access– Requires hand-marked paper ballots, which could be a barrier for certain voters with disabilities, etc.
